







City of Danville Logo & DKY Mark (Uncoated Paper)







City of Danville Logo & DKY Mark (Coated Paper)







All Branded Materials

The City of Danville has four official colors. These are vivid blue for uncoated paper stock (PMS 2985 U), vivid blue for coated paper stock (PMS 298 C), light gray (PMS 442 U), and dark gray (PMS 445 U).

Pantone color formulas are provided to ensure accurate and consistent reproduction of the color palette. The Pantone Matching System (PMS) is designed for use in printing, so using the provided color formulas for other materials may not accurately match the official colors. In these cases, color swatches should be provided to the vendor so that the official colors can be replicated and matched exactly.





The City of Danville has two official font families that should be used in publications. The primary font is the Brandon Grotesque font family and the secondary font is the Garamond font family. Brandon Grotesque may be used for headlines, subheads, pull-out quotes, and body copy. Garamond should only be used for body copy. Consistent use of these fonts will assure that the city maintains its brand look.
